- The Limited Review of the above result has been carried out by the Statutory Auditors of the Company.
- The above unaudited result are reviewed and recommended by the Audit Committee and taken on record by the Board of Directors at its meeting held on 25th August, 2016.
- The Company does not have any Exceptional or Extraordinary Item to report for the above periods.
- Gross Income comprises Gross Sales / Income from Operations, Other Operating Income and Other Income.
- The networth of the Company has eroded and turned into negative due to losses incurred by the Company during the previous year ended 31st March, 2015, consequent to which, the Company has become a Sick Industrial Company within the meaning of 3(1)(o) of the Sick Industrial Companies (Special Provisions) Act, 1985. A reference to the Board for Industrial and Financial Reconstruction (BIFR) has been made in this regard. The management is of the view that the Company will be in a position to generate positive cash flows and adequate profitability in future and hence these final statements have been drawn up on a going concern basis.
- This statement is as per SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.
- Since sugar is a seasonal industry, the figures of the current period are not representative of the performance of the Company for the year ended 31st March, 2017.
- Adjustments on account of Deferred Taxation as per Accounting Standard 22 as issued by The Institute of Chartered Accountants of India (ICAI) shall be made at the end of the year.
- Provision in respect of current tax shall be made at the end of the year.
- The main business of the Company is manufacture of sugar and all other activity of the Company revolves around the main business. There are accordingly no separate reportable segments as per the Accounting Standard 17 - Segment Reporting issued by ICAI.
